Parent/Guardian Agreement

By registering with St Catharines CYO Minor Hockey League in the current year, I agree to the Terms and Conditions (Parent/Guardian Agreement) of St. Catharines CYO Minor Hockey Association.

I, being a parent/guardian of the child named on the St Catharines CYO Minor Hockey Player Registration Form:

1. Grant Permission for my child/ward to participation in the St. Catharines Diocese CYO Minor Hockey League Corporation and all activities associated therewith, assuming all risks and hazards incidental to such participation including transportation to and from such activities;
2. Agree to return upon request, the uniform and other such equipment issued to our child/ward in as good condition as when received, except for normal wear and tear;
3. Agree to Produce a copy of a certified birth certificate of the above named candidate to league officials as requested;
4. Warrant and Represent that my child/ward has no medical problems that prevent him/her from fully participating in games, practices and any other activities of any kind whatsoever associated with the operation of the St. Catharines Diocese CYO Minor Hockey League Corporation;
5. Agree to Indemnify and Save Harmless the St. Catharines Diocese CYO Minor Hockey League Corporations, its directors and officers, employees or volunteers, members, affiliated associations. Coaching staff (including all coaches, trainers, managers and assistants). Sponsors, on-ice officials, ice facility operators and employees or any other person or body associated with the operations of the St. Catharines Diocese CYO Minor Hockey League Corporation and/or league team from and/or against all liabilities for any injuries or other damages however occurring to my child/ward as a result of his/her participation in the activities of the of the St. Catharines Diocese CYO Minor Hockey League Corporation and/or league team, notwithstanding that the injuries or damages may have been caused or contributed to by the actions of negligence of any persons or organizations identified above in the paragraph. Acknowledge that by signing and submitting this application, I that have read, understood and agree to this indemnity agreement.
6. Agree and Acknowledge that my child/ward will not play with any other hockey organization while playing with the St. Catharines Diocese CYO Minor Hockey League Corporation and/or league team;
7. Acknowledge that the St. Catharines Diocese CYO Minor Hockey League Corporation reserves the right to transfer any player/players to any CYO Parish Association other than the one requested in accordance with its internal transfer policy;
8. The St. Catharines Diocese CYO Minor Hockey League Corporation reserves the right to refuse admission, limit admission or eject any person admitted to its program;
9. Acknowledge that no participant in the hockey program will be allowed to commence participation or to continue participation if his/her fees are not paid as required. There will be a \$25.00 surcharge for any dishonoured payments;
10. I consent, as the parent or guardian, to have my child's name, photograph, video image and/or accomplishments being released to the media and to be used in CYO publications (newsletters, tournament programs, etc.)
11. Have read and understand the Refund Policy of the St. Catharines Diocese CYO Minor Hockey League Corporation.
